Introduction:

Investment is considered one of the important mechanisms for achieving sustainable economic development. Considering of the importance of developing an open, attractive, integrated, and effective environment for investment requires frequent updates of legislative, judicial, financial, and technical infrastructure, Arab countries have attempted to develop investment laws to involve investment advantages, facilities, and grants as well as setting out effective mechanisms for settling disputes.

- 2- Researches are accepted in Arabic , English or French and the research has a summary in Arabic (Not Exceeding 250 words)
- 3- The first page must include the title of dissertation , name of researcher and name of institution / university and the research begins with the summary then the remaining research starting with the introduction and ending in the list of references.
- 4- The whole number of the research pages (with its annexes) must not exceed 30 pages in relation to one research including all drawings, diagrams . tables and list of references.
- 5- the font type used in researches is “ Simplified Arabic” , font size is (14 not bold) , margins are in the same font type with font size (12) . The main headings are in the same font type with font size (16 bold) and secondary headings are in the font size (14 bold)
- 6- The submitted researches are scientifically refereed by specialists in the field of research.
- 7- The unaccepted researches are not returned to their researchers.

Bearing in mind that the deadline of receiving the summary of the scientific paper is January 10th and the whole scientific paper March 15th 2019
